In the presence of myelin oligodendrocyte glycoprotein (MOG) antibodies, this risk is estimated to be as high as 50-70% when both MS antibodies are present simultaneously. In our patient, both MS and SLE antibodies were detected in the CSF. Based on these findings, it is likely that the two disorders were coexistent, although it is still possible that the clinical manifestations of MS preceded those of CIDP.
